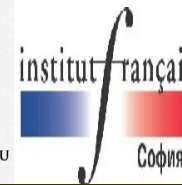

The Université Montesquieu - Bordeaux IV, France, is the heir of the Faculty of Law and Economic Sciences which dates back to the 15th century.

The Financial Management Master's Programme

Successful graduates obtain **two national diplomas**: a Bulgarian Master's degree diploma from the Sofia University "St. Kliment Ohridski" and a French Master's degree diploma from the Université Montesquieu - Bordeaux IV.

The main **objective** of the Financial Management Master's programme is to give a professionally oriented education to those wanting to specialize in the different aspects of corporative finance: investment, financing, risk-management, relations among shareholders, managers and creditors, deontology and business ethics.

Graduates of the programme can find **professional realization** in numerous spheres and mainly as financial analysts and managers in industrial and commercial enterprises, banks and government institutions.

Admission Conditions and Course of study

All candidates must hold a **Bachelor's or a Master's degree in Economics or Business Administration**. Holders of non-Bulgarian diplomas must present diplomas certified by the Bulgarian Ministry of Education and Sciences.

The **main language** of the Financial Management Master's programme is **French**. However, some courses may be given in **English**, so all students must be able to use both languages.

The admission process includes the following elements:

- a fulfilled admission form;
- letter of motivation;
- Curriculum Vitae
- Diploma with accompanying detailed academic record
- Document certifying the payment of the non-refundable application fee.

Candidates are then invited to an interview before a selection panel of Bulgarian and French professors and representatives of the French Institute.

The academic year starts in November 2008 and the Master's programme is organized in 3 semesters.
