In keeping with the National Programme "Young Scientists and Post-doctoral Fellows – phase 2" (more at https://web.mon.bg/bg/101140) and the updated National Strategy for the Development Research the Republic Scientific in of Bulgaria 2017-2030 (more http://www.strategy.bg/StrategicDocuments/View.aspx?lang=bg-BG&Id=1231) the *Faculty* of Philosophy at Sofia University St. Kliment Ohridski announces a competition for selecting young scientists¹ and post-doctoral fellows.²

You can apply under the programme by submitting:

- Sample documents
- A research project application form

I. APPLICATION DOCUMENTS

- 3. Copies of the diploma certifying successful completion of the **first** Master's degree, and the **first** PhD degree respectively
- 4. Copy of the enrollment order (applicable to applicants who are currently enrolled as parttime doctoral students or independent doctoral students)
- 5. Copy of the employment contract (applicable to candidates appointed to the position of "assistant" or "chief assistant").

All application documents have to be saved in files, each named in Latin, with the applicant's surname first initial. followed by the name of the document (e.g.IvanovI Statement Young Res Post-doc; IvanovI CV; IvanovI diploma-MA; IvanovI_diploma-MA/PhD; IvanovI_enrolment_order; IvanovI_employment_contract).

All documents 1-4 are placed in a separate folder with a name in Latin, including the surname and initial of the first name of the applicant and "Documents" (e.g. IvanovI_ Documents).

¹ A "Young scientist" is a person who carries out scientific research and scientific-educational activities in a higher education institution and/or scientific organisation after acquiring their first education and qualification degree of "Master", but not more than 10 years after its acquisition. The date of the Protocol of the State Examination Committee is considered date of the master's degree acquisition.

² A "post-doctoral fellow" is a scientist who has acquired their first doctoral degree in Bulgaria or abroad, within 5 years of acquiring it. The scientific and educational degree of "Doctor" is considered acquired as at the day when the dissertation work is defended successfully.

The eligibility grounds for both categories of applicants must be valid not only at the time of application, but throughout the entire period of their participation after signing a contract under the programme.

II. EVALUATION OF THE RECEIVED PROPOSALS AND SELECTION

A Faculty Committee, elected by the Faculty Council of the Faculty of Philosophy, Protocol №15 of 19.07.2022, approved by the Academic Council of Sofia University, Protocol № 17 of 19.08.2022 And appointed with Order of Rector of Sofia University № RD-19-280 of 22.08.2022 evaluates the submitted applications.

THE SELECTION OF APPLICANTS GOES THROUGH THREE STAGES:

- 1. FIRST STAGE: eligibility check of applicants.
- 1.1. Eligibility of the applicants for participation in the competition in the categories of "young scientist" and "post-doctoral fellow".
- 1.2. Review of the received documents.

The review of the received documents is carried out by the representatives of the doctoral students - members of the Committee. Based on the results of the review, the Committee makes a decision on the applicants'eligibility.

The applicants who do not meet some of the specified requirements for administrative compliance are sent a notice of termination of the application procedure. This termination is not subject to appeal.

- 2. **SECOND STAGE** evaluation of the research results and the proposal for participation in the project applied for
 - 2.1. Evaluation of the scientific research results of the applicants for the past 5 years according to the announced criteria. The evaluation according to these criteria is carried out by the representatives of the doctoral students members of the Committee. Based on the evaluation data, the Committee ranks the candidates according to these criteria.

The results of the specified criteria form 10% of the assessment of the applicants' scientific potential.

2.2. Evaluation of the proposal for participation in the project applied for according to the criteria prepared by the Committee. The evaluation is carried out by the habilitated academics - members of the Committee according to the attached expert evaluation card. The authorised representatives in the Committee decide on the evaluation of each candidate by a simple majority.

Applicants whose proposals are not prepared according to the attached sample forms will not be evaluated.

The result of the expert evaluation of a proposal for participation in the project applied for forms 90% of the assessment of the scientific potential of the applicants.

All proposals which receive an evaluation of no less than 15 points will be admitted to the third stage of evaluation. All applicants who have successfully passed the second stage of the procedure will receive personal messages about this along with an invitation to participate in the third and final stage - an interview according to a fixed schedule.

All applicants who have not successfully passed the 15-point threshold at their proposal evaluation, will receive a personal message with the result of the competition. Upon request, which can be submitted within 7 days of the date of notification, applicants can receive the expert evaluation card concerning the evaluation of their project proposal. This information will be provided within 24 hours of the request.

3. *THIRD STAGE*: interview.

During the interview, applicants have to demonstrate knowledge and skills to work on the project they are applying for and answer questions from the habilitated academics - members of the Committee. Their performance will be evaluated on the following scale:

- 1. Very poor performance − 1 point
- 2. Poor performance -2 points
- 3. Good performance 3 points
- 4. Very good performance 4 points
- 5. Excellent performance 5 points

Based on the results of the three stages of the selection, the Committee ranks the applicants for young scientist and and post-doctoral fellow positions and proposes to the Faculty Council of the Faculty of Philosophy to vote for their approval. After the decision of the Faculty Council of the Faculty of Philosophy, the approved candidates are proposed for appointment on an employment contract for a period of no less than 6 (six) months.

III. ANNOUNCEMENT OF THE RESULTS

The results of the competition are published on the website of the Faculty of Philosophy after its completion. The information is disclosed under the incoming reference number received in the process of application.
