

CONSTITUTIONAL AND QUASI-CONSTITUTIONAL CONSTRAINTS

- > CONSTITUTIONALISATION OF POLITICS: CONSTRAINTS, LIMITS ON THE POWER OF DEMOCRATICALLY ELECTED MAJORITIES
- > OVER-CONSTITUTIONALISATION:
- ▶ IN EE CONSTITUTIONAL CONSTRAINING WENT FURTHER THAN THE TRADITIONALLY ACCEPTED DUE MAINLY TO THE EU PRE-ACCESSION PROCESS. THIS PROCESS HELPED STRENGTHEN THE CONSTRAINING OF THE POWERS OF POLITICAL MAJORITIES MAINLY THROUGH THE EXPLICIT REINFORCEMENT OF A SPECIFIC CROSS-PARTY "TRANSITION CONSENSUS" EMBEDDED IN THE EU CONDITIONALITY (FORMAL AND INFORMAL).
- ▶ THE SUBSTANCE OF THIS CONSENSUS WAS THE POLITICAL COPENHAGEN CRITERIA TOGETHER WITH THE REQUIREMENT FOR "FUNCTIONING MARKET ECONOMY" "CAPABLE OF WITHSTANDING COMPETITIVE PRESSURES". NO SERIOUS POLITICAL ACTOR COULD DEVIATE FROM THESE COMMITMENTS, WHICH GAVE THEM A QUASI-CONSTITUTIONAL STATUS.

- \succ Ratification of the Fiscal Compact of EU 2012
- > Political: NATO, EU, CVM, RULE OF LAW CONDITIONALITIES, RECOVERY AND RESILIENCE FUND CONDITIONALITIES
- ▶ JUDICIAL CONSTRAINTS: POWERFUL CONSTITUTIONAL COURT WITH ACTIVIST POLICIES IN A NUMBER OF POLICY AREAS (CONSTITUTIONAL REFORMS, CONSTITUTIONAL IDENTITY, ETC.)

STABLE CONSTITUTIONAL CONSTRAINTS ON POLICIES PRODUCE **RADICALISATION OF DEMOCRATIC POLITICS**

- Political radicals and populist newcomers radicalise their demands
- IN CARTELISED, OVERCONSTITUTIONALISED SYSTEMS, IN ORDER TO PRODUCE EVEN A RELATIVELY SMALL POLICY CHANGE POLITICIANS NEED TO THREATEN DISMANTLING THE SYSTEM AS A WHOLE.
- This is a slippery slope, which leads to escalation of threats and demands. THERE ARE ALREADY PARTIES IN BULGARIA CAMPAIGNING FOR EU AND NATO EXIT.

CONCLUSIONS

- \succ Constitutionalisation and over-constitutionalisation of policies has STABILISING POLICY EFFECT IN POLICRISES: BULGARIA REGISTERS HEALTHY ECONOMIC GROWTH AND DESPITE THE POLITICAL TURBULENCE HAS CHANCES FOR EUROZONE MEMBERSHIP.
- \succ However, constitutionalisation and overconstitutionalisation over time has a RADICALISING EFFECT ON POLITICS: ANTI-ESTABLISMENT PARTIES BECOME MORE RADICAL IN THEIR DEMANDS AND AGENDAS.
- > STABLE POLICIES BUT UNPREDICTABLE, POLARISED AND RADICALISED POLITICS IS A SIGN OF RESILIENCE OF THE SYSTEM, BUT ALSO OF ITS VULNERABILITY. RADICALISATION AND POLARISATION WILL VERY LIKELY HAVE NEGATIVE MEDIUM-TERM AND LONG-TERM EFFECTS.

- > EACH CASE INVOLVES ONE OR TWO ORAL EXAMINATIONS IN A SPECIFIC UNIVERSITY. MOSTLY. THE STUDY FOCUSES ON EUROPEAN UNIVERSITIES WITH TWO CASES FROM OTHER CONTINENTS - NORTH AMERICA AND ASIA.

IN THIS STUDY, WE ARE EXPLORING THE CASUAL RELATIONSHIPS BETWEEN VALUES ATTITUDES AND SKILLS ON THE ONE HAND. AND CIVIC AND POLITICAL ENGAGEMENT ON THE OTHER

- DATA IS COLLECTED BY USE OF VALIDATED TOOLS SWARTZ PORTRAIT VALUE QUESTIONNAIRE INTERNATIONALLY VALIDATED (SCHWARTZ ET AL. (2016); THE 2016 INTERNATIONAL CIVIC AND CITIZENSHIP EDUCATION STUDY (ICCS) (SCHULTZ ET AL, 2017); 7 SPECIFIC ATTITUDES AND SKILLS OUT OF THE 20 SPECIFIED BY THE REFERENCE FRAMEWORK OF COMPETENCES FOR DEMOCRATIC CULTURE (RFCDC) (COUNCIL OF EUROPE, 2018) - CHOSEN BECAUSE THERE ARE WELL-ESTABLISHED INTERNATIONALLY VALIDATED MEASURES FOR THESE 7 ATTITUDES AND SKILLS (THE MEASURES ARE TAKEN FROM THE OECD PISA 2018 ASSESSMENTS OF GLOBAL COMPETENCE)
