Sofia University "St. Kliment Ohridski" is the first Bulgarian academic and higher education institution. Its history is embodiment and continuation of centuries-old cultural and educational tradition of the Bulgarian nation. Currently, it is the country's largest and most prestigious university. Its leading role on the national roadmap of educational institutions and R&D structures, its participation in numerous European and international projects and research networks determine its responsibility in creating and implementing modern policies of national, regional and international importance, which are also reflected in its mission.

The University's mission is fully aligned with its leading role in the area of education policies, innovations, technology transfer, entrepreneurial skills development, digitalization, training and research connectivity. It is focused on students' education in all degrees – Bachelor, Master and PhD, as well as on developing of environmentally responsible institutional models for research, applied and educational aspect and their implementation in the society. This Strategy is in line with the European institutional values, the sustainable development principles, environmental and social standards. It corresponds to the National Development Program "Bulgaria 2030" and envisages realistic measures in short, medium, and long term in the key university activities.



The UN Sustainable Development Goals are important because they do not only impact the sustainable development in general. They are related to all important topics of modern times, incl. poverty and overcoming inequalities. They cannot be achieved by one country or only one type of institution. That is why a global network covering the whole world is the most appropriate, and universities are leaders in this movement. Sofia University can play a key and leading role in this regard, because by starting from sustainable campuses and educating future leaders on sustainable development, we can be even more useful to society.

To achieve these ambitious objectives, Sofia University has adopted its own Strategy and a specific Action Plan for climate mitigation and adaptation. These are two strategic documents that will help us not to move chaotically for the next five years, but to work systematically on our progress.

A working group appointed by the Rector defined the targets of the United Nations Sustainable Development Goals (SDGs) that can be achieved through various projects, activities and initiatives. The process starts with drafting an initial list of material issues.
