The Doctoral School of the Faculty of Law and Administrative Sciences within the West University of Timisoara, in cooperation with the European Centre for Legal Studies and Research of Timisoara, organises the International Conference of PhD Students in Law – the third edition – at Timisoara, on April 15th 2011.

The aim of this event, the only one of its kind in Romania, considering the number of participants and its academic rigour (at our former edition, in 2010, two conference volumes were published, containing 136 studies, amounting to 1494 pages), is to give an impetus to PhD students in law to promote their research, by facilitating the publication of their results, as well as to establish cooperation between the participating faculties.

PhD students from the most prestigious national and European faculties of law are invited to take part in the conference. The articles sent to be published can be written in Romanian, English, French or German. The papers written in Romanian must be preceded by a summary of the study, in English, French or German.

The conference volume will be published by a recognised publisher in Romania (Wolters Kluwer), which guarantees its highly academic and graphic contents and will be handed to the participants on the occasion of the event. At the same time, the volume will be sent to the libraries of the participating faculties, as we have proceeded on our previous editions.

The presentations of the Public and Private law Sections will be moderated by professors of the Faculty of Law and Administrative Sciences within the West University of Timisoara.

The organisers advise the academic visa of the presented papers by the PhD thesis supervisor.
