Concept

The Model WTO is a student initiative that provides a unique opportunity for future decision-makers to face important global issues within the simulation framework of the WTO ministerial negotiations. Every year since 1997, students from all around the world are invited to Switzerland to debate and exchange creative ideas in the exceptional context of the World Trade Organization.

Objectives

Our objective is to sensitize our student audience to the current issues of international trade as well as to enable the participants to have a unique insight into the procedure for adopting trade resolutions. In that sense, the Model WTO offers a unique experience for students to get involved in a high-level training and benefit from the expertise of WTO professionals. In addition, our goals are more than academic: we seek and encourage the exchange of knowledge, the meeting of international students from different backgrounds, and the active participation of young people in today's society.

Organization

The upcoming conference will be held from April 2nd to April 9th, 2020, at the campus of the University of St. Gallen as well as at the WTO headquarters in Geneva. The event is organized by 8 students of the University of St. Gallen who are supported by an advisory board of experts in international trade to ensure the quality of the simulation. Moreover, the conference will be supervised by a team of 14 additional students from the University of St. Gallen who will undertake the role of chairs and will be actively involved in the negotiations.



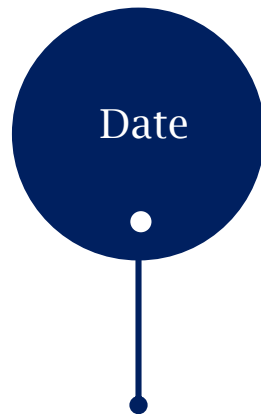

03 | Topic - Environmental Sustainability and the WTO

The discourse surrounding environmental degradation has been rapidly developing in the public and political spheres in the past few years. Around the globe, nations are becoming increasingly vulnerable to the challenges presented by climate change and environmental degradation. Although the topic has received central attention at the United Nations Climate Action Summit in September 2019, the World Trade Organization has yet to embrace a more proactive role in this matter.

As mentioned in the founding documents of the WTO, sustainable development, as well as the protection and preservation of the environment are fundamental goals of the WTO. Therefore, the 23rd Edition of the Model WTO will focus on the role of the WTO and its Member States, and how they can begin to truly fulfill these objectives. The goal of the students' deliberations is to provide a comprehensive framework of possible solutions and negotiate an **Agreement on Sustainable Trade and Environment**.

Delegates

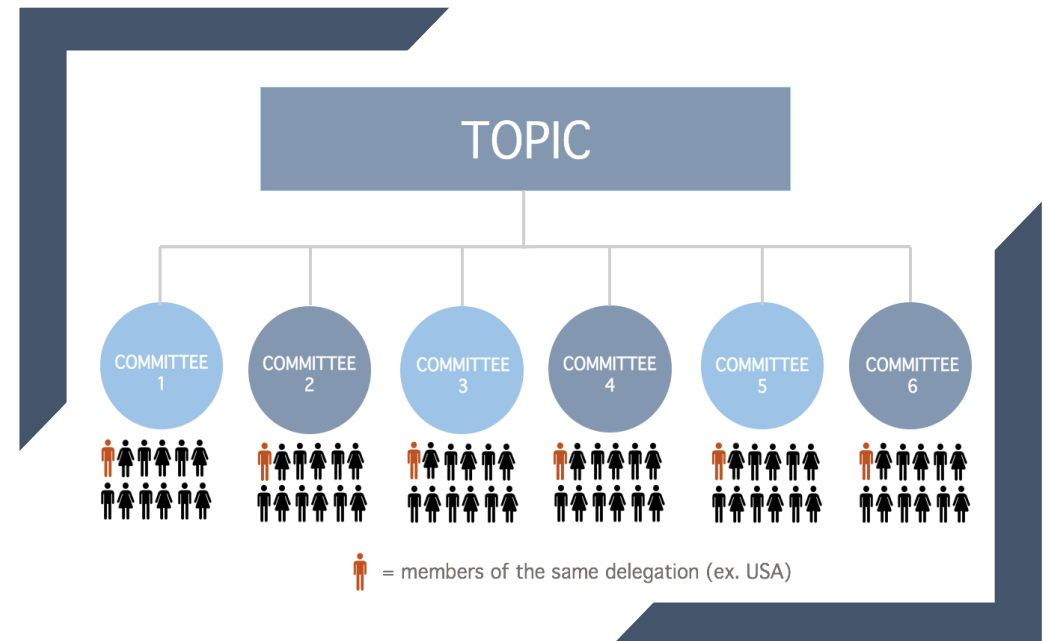
The role of the conference's participant is to represent the delegate of one of the 12 countries present in one of the 6 committees.

The delegate's main contribution comes during the negotiations of Committee resolutions during which participants are tasked with defending the views and interests of their represented countries.

Head Delegates

Head Delegates represent a group of 6 participants that set the confidential negotiation goals for one of the 12 countries they represent.

At the beginning of the week, Head Delegates are responsible for aligning the position of the delegation for the conference's debates and negotiations.

Application Timeline



Applicants will need to submit their CV, an essay along with a short motivational letter by the application deadline. Upon acceptance the participants will be asked to provide us with their country/committee preferences and they will be allocated accordingly. Following the final selection, participants must submit the payment for the participation fees within two weeks.









































The participation fee has not yet been determined. For reference, last year's fees amounted to CHF 370.
